Mr Tanner presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

These amendments require that, where advice from the Fund advisory boards supports infrastructure expenditure estimated to be above a threshold amount of \$50,000,000 (or a lower amount prescribed in regulations), the advice be referred to a new Parliamentary Joint Committee on Nation-building for consideration and report.

These amendments are not supported because the Nation-building Funds Bill 2008 already provides for rigour, transparency and scrutiny in relation to the evaluation and payment processes for the Building Australia Fund (BAF), the Education Investment Fund (EIF) and the Health and Hospitals Fund (HHF). Spending on specific projects will be assessed by independent advisory boards against evaluation criteria. The evaluation criteria are legislative instruments which are disallowable by the Parliament.

The Government will consider which of the projects will be funded through the budget process and it will include details of infrastructure payments in the budget documentation.

Parliamentary transparency and scrutiny for payments from the Funds will also be provided by the general drawing rights limit, which will be included in the annual Appropriations Acts for the financial years 2009-10 onwards. The general drawing rights limit restricts the total amount that may be paid out in a financial year to support relevant infrastructure expenditure, which gives the Parliament a mechanism by which it may oversight the rate at which amounts are being expended.

On the basis that the arrangements provide for rigour, transparency and scrutiny in the evaluation and payment framework, the establishment of a new committee imposes an unnecessary further review of payments from the Funds that is not required to ensure the efficacy of the funding decisions.

The amendments also propose that portfolio Ministers must provide to both Houses a written statement of reasons for a recommendation of a payment from the Funds. The amendments further propose that a portfolio Minister must not make a recommendation unless he or she has received advice from the Fund advisory board on whole of life costs being met by the asset owner and that the project will not require upfront fees; also that in giving that advice, Fund advisory boards also take into account the application of the Competitive Neutrality Guidelines, if applicable.

Due to the rigour, transparency and scrutiny provided in the Nation-building Funds Bill 2008, these amendments are not required and are therefore not supported. As well, these amendments will delay the accelerated implementation of the Nation-building Funds, an important step to protect Australians against the fall-out from the global financial crisis. Managing whole of life costs are already factored into the evaluation process, and are reflected in the interim EIF evaluation criteria and interim HHF evaluation criteria.

It also needs to be recognised that upfront fees are appropriate in certain circumstances. Prohibiting upfront fees could lead to less co-investment from certain sectors, such as with higher education institutions. The Commonwealth's interests would be protected through Funding Agreements, as with other grants. Existing policy obligations will also apply to the Funds where relevant, including in relation to competitive neutrality.

The amendments also propose that determinations to credit the Funds are disallowable instruments. Normally such determinations would be regarded as administrative, rather than legislative, in character. However, to provide transparency to the Parliament, these crediting determinations have been made non-disallowable instruments. These arrangements are the same as those in the Future Fund Act 2006 and the Higher Education Endowment Fund Act 2007. Therefore, these amendments are not supported.

The disclosure of advice from Infrastructure Australia and other advisory boards through further amendments are not supported. Arrangements contained in the Nation-building Funds Bill 2008 provide for rigour and transparency in making payments. Additionally, these amendments could result in commercial in confidence information being disclosed, which could affect how applicants participate.

The amendments also oppose the proposal to transfer the balance of the Communications Fund to the BAF.

Not transferring the balance of the Communications Fund to the BAF will affect the delivery of the proposed National Broadband Network (NBN). The NBN is expected to deliver significantly improved telecommunication services to rural and remote areas. The inability to utilise the capital will severely restrict the nature and extent of the telecommunications infrastructure able to be provided to all areas of Australia.

Accordingly, the House of Representatives does not accept the amendments.
