 - To The Honorable Charles McDonald, Speaker of the House of Representatives of the Commonwealth of Australia.

Greeting :

WHEREAS by the forty-second section of the Constitution of the Commonwealth of Australia it is enacted that every Member of the House of Representatives shall, before taking his seat, make and subscribe before the Governor-General, or some person authorized by him, an Oath or Affirmation of Allegiance in the form set forth in the Schedule to the aforesaid Constitution :

Now THEREFORE I, the Governor-General aforesaid, do by these Presents command and authorize you from time to time in the Parliament House of the Commonwealth in the City of Melbourne to administer the said Oath to such Members of the House of Representatives as have not already taken and subscribed the same since their election to the said House of Representatives.

Given under my Hand and the Seal of the Commonwealth of Australia, at Melbourne, this eighth day of October, in the year of our Lord One thousand nine hundred and fourteen.

- 5. CHAIRMAN OF COMMITTEES. Mr. Fisher moved, by leave, That the honorable Member for Riverina (the Honorable John Moore Chanter) be appointed Chairman of Committees of this House. Debate ensued. Question-put and passed.
- 6. CONCILIATION AND ARBITRATION BILL (1914). -The Order of the Day having been read for the second reading-Mr. Hughes moved, That the Bill be now read a second time. Debate ensued.

Question-put and passed.-Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses I and 2 agreed to. Title agreed to. Bill to be reported without amendment.

The House resumed ; Mr. Chanter reported accordingly.

On the motion of Mr. Hughes, the House adopted the Report.

Mr. Fisher moved, by leave, That the Standing Orders be suspended so as to allow the Bill to be passed through its remaining stage without delay, and before the Address in Reply is agreed to. Question—put and passed.

On the motion of Mr. Hughes, the Bill was read a third time.

- 7. SUSPENSION OF STANDING ORDERS-SUPPLY.--Mr. Fisher moved, That the Standing Orders be suspended in order to enable the Committees of Supply and Ways and Means to be appointed before the Address in Reply to His Excellency the Governor-General's Opening Speech has been agreed to by the House, and to enable all other steps to be at once taken to obtain Supply. and to pass the Supply Bills through all their stages without delay.
 - Question -- put and passed, with the concurrence of an absolute majority of the Members of the House.
- 8. SUPPLY .- Mr. Fisher moved, That the House do now resolve itself into a Committee to consider the Supply to be granted to His Majesty. Question-put and passed.
- 9. SUPPLY RESOLUTIONS [SUPPLY BILLS].-The House then resolved itself into the Committee of Supply.

SUPPLY BILL (No. 2) 1914-15.

Resolved, on the motion of Mr. Fisher, after debate—That a sum not exceeding Three million two hundred and twenty-seven thousand two hundred and eighty-six pounds be granted to His Majesty for or towards defraying the services of the year ending 30th June, 1915.

SUPPLY (WORKS AND BUILDINGS) BILL (No. 2) 1914-15.

Resolved, on the motion of Mr. Fisher-That there be granted to His Majesty to the service of the year 1914-15, for the purposes of Additions, New Works, Buildings, &c., a sum not exceeding £366,150.

Resolutions to be reported, and leave asked to sit again.

The House resumed ; Mr. Chanter reported accordingly. Resolved—That the House will, at its next sitting, again resolve itself into the said Committee. The Resolutions reported from the Committee were read and, on the motion of Mr. Fisher, were adopted.

10. WAYS AND MEANS .-- Mr. Fisher moved, That the House do now resolve itself into a Committee to consider the Ways and Means for raising the Supply to be granted to His Majesty. Question-put and passed.

11. WAYS AND MEANS RESOLUTIONS .-- The House then resolved itself into the Committee of Ways and Means.

SUPPLY BILL (No. 2) 1914-15.

Resolved, on the motion of Mr. Fisher, after debate-That towards making good the Supply granted to His Majesty for the services of the year ending 30th June, 1915, a sum not exceeding Three million two hundred and twenty-seven thousand two hundred and eighty-six pounds be granted out of the Consolidated Revenue Fund.

SUPPLY (WORKS AND BUILDINGS) BILL (No. 2) 1914-15.

Resolved, on the motion of Mr. Fisher, after debate—That towards making good the Supply granted to His Majesty for Additions, New Works, Buildings, &c., for the year 1914-15, a sum not exceeding Three hundred and sixty-six thousand one hundred and fifty pounds be granted out of the Consolidated Revenue Fund.
