7. THE WAR-APPEAL BY HIS MAJESTY THE KING .- Mr. Hughes read to the House the following cablegrams :---

Copy of Cablegram received by His Excellency the Governor-General from the Secretary of State, dated London, 22nd October, 1915.

"Following Message from His Majesty the King headed Buckingham Palace will be published to-morrow morning (Saturday) :--

"To My People-

"At this grave moment in the struggle between my people and a highly organized enemy who has transgressed the law of nations and changed the ordinance that binds civilized Europe together I appeal to you.

"I rejoice in my Empire's effort, and I feel pride in the voluntary response from my subjects all over the world who have sacrificed home, fortune, and life itself in order that another may not inherit the free Empire which their ancestors and mine have built.

"I ask you to make good these sacrifices.

"The end is not in sight. More men and yet more wanted to keep my armies in the field, and through them to secure victory and enduring peace.

"In ancient days the darkest moment has ever produced in men of our race the sternest resolve.

"I ask you, men of all classes, to come forward voluntarily and take your share in the fight.

"In freely responding to my appeal you will be giving your support to our brothers who for long months have nobly upheld Britain's past traditions and the glory of her arms.

"GEORGE R.I."

Copy of Cablegram despatched by His Excellency the Governor-General to the Secretary of State for the Colonies on the 25th October.

I feel confident that Your Majesty's Message will evoke patriotic response from the people of the Commonwealth and will tend greatly to augment the ranks of the 160,000 Australians who have already provided an assurance of the wholehearted co-operation and determination of Australia to carry the war to a successful issue.

8. ADJOURNMENT .- Mr. Hughes moved, That the House do now adjourn.

Debate ensued. Question—put and passed.
