In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the War Loan (United Kingdom) Act 1914-1916 and the War Loan (United Kingdom) Act 1915-1916.
