THE WAR AND THE ALLIED ARMIES.—Mr. Hughes, moved by leave, That this House records its unbounded admiration of the heroic efforts of the Allied Armies on the Western front, its pride in the valour and achievements of the Australian troops, and its firm intention to fight on to secure a victorious peace and the freedom of the world.

Mr. Higgs moved, as an amendment, That all the words after the word "troops" be omitted from the motion with a view to the insertion of the following words in place thereof:—

"and in order that the sacrifice of valuable human lives may be stopped, and an end put to intolerable human suffering, this House is not opposed to peace by negotiation".
