VOTES AND PROCEEDINGS OF THE HOUSE OF REPRESENTATIVES.

FRIDAY, 22ND AUGUST, 1919.

1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. PAPER.—The following Paper was presented, pursuant to Statute—
Public Service Act—Promotion of T. O'Callaghan, Attorney-General's Department.
3. IMMIGRATION BILL (1919).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—
