- 1. The House met, at three o'clock p.m., according to the terms of the Resolution of the 27th May last.

 -Mr. Speaker took the Chair, and read Prayers.
- 2. CONGRATULATIONS TO MR. SPEAKER (SIR ELLIOT JOHNSON, K.C.M.G.).—Mr. Hughes, on behalf of the Government, congratulated Mr. Speaker upon the Knighthood which His Majesty the King had conferred upon him.

Mr. Tudor and Mr. McWilliams also congratulated Mr. Speaker.

Mr. Speaker expressed his thanks for the congratulations tendered to him.

- 3. MINISTRY—RESIGNATION OF TREASURER (Mr. Watt).—Mr. Hughes announced to the House that Mr. Watt had resigned his office as Treasurer of the Commonwealth.
- 4. Ballaarat Electoral Division.—Order of the Court of Disputed Returns.—The Clerk laid upon the Table a letter which he had received from the Principal Registrar of the High Court at Melbourne, forwarding a copy of an Order, made on 2nd. June last, declaring the election held on 13th December last, for the Electoral Division of Ballaarat, in the State of Victoria, to be absolutely void. Question—put and passed.
- 11. PARLIAMENTARY STANDING COMMITTEE ON PUBLIC WORKS .- Mr. Gregory, Chairman of the Parliamentary Standing Committee on Public Works, brought up the following Report from the

Report, together with Minutes of Evidence and Plans, relating to the proposed Erection of Mobilization and Vehicle Stores at Seymour, Victoria.

Ordered—That the Paper be printed.

- 12. DESTITUTE ALLOWANCE.—Mr. W. Maloney moved, pursuant to notice—
 - (1) That this House is of opinion that the Invalid and Old-age Pensions Act should be amended in order to provide for a destitute allowance to be made to all inhabitants who are destitute, so that any person making a statutory declaration (to a postmaster, Customs officer, or other appointed Commonwealth official, a schoolmaster, a union secretary, a magistrate, or other appointed individual) that he or she is insufficiently fed, clothed, or sheltered, shall be paid as soon as possible the sum of 15s. per week, and for each child 7s. 6d. per week, until relieved.
 - (2) That the passing of the foregoing resolution be an instruction to the Government of the Commonwealth to bring in the necessary amending Act.

Debate ensued.

- Mr. Prowse addressing the House and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.
- Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for Thursday next.
- · 13. POSTPONEMENT OF NOTICES OF MOTION.—Ordered—That Notice of Motion No. 2 be postponed until Thursday next; No. 3 until Thursday, 5th August; No. 4 until Thursday next, and No. 5 until Thursday, 29th instant.
 - 14. Broken Hill Mining Industry—Royal Commission.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Considine:-
 - (1) That a Royal Commission be appointed to investigate and report upon the conditions in . connexion with the mining industry at Broken Hill, and more particularly with regard to (a) cost of production of output; (b) wages of employees; (c) hours and other conditions of labour; (d) health of those engaged in the industry, and the causes of the undermining thereof; (e) selling prices and conditions of or in connexion with the sale of metals and other output; (f) profits arising from the industry and its method of distribution.
 - (2) That such Royal Commission shall have power to summon witnesses and examine them on oath, and to order the production of such papers as the Commission may consider necessary for the purposes of the investigation, and shall have all such other powers as the Royal Commission may consider necessary for effectively performing their functions-
