PARRAMATTA ELECTORAL DIVISION—ISSUE OF WRIT.—Mr. Speaker announced to the House that he had yesterday issued a Writ for the Election of a Member to serve for the Electoral Division of Parramatta, in the State of New South Wales, in the place of the Right Honorable Sir Joseph Cook, P.C., G.C.M.G., resigned. The dates appointed in the Writ were as follow:—
