## THURSDAY, 17th AUGUST, 1922.

- The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Messages from the Governor-General.—Estimates, 1922-23.—The following Messages from His Excellency the Governor-General were presented, and the same were read by Mr. Speaker:—

#### FORSTER

Governor-General.

Message No. 6.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General transmits to the House of Representatives Estimates of Revenue and Expenditure for the year ending the thirtieth day of June, One thousand nine hundred and twenty-three, and recommends an appropriation of the Consolidated Revenue Fund accordingly.

The House resumed; Mr. Fleming reported accordingly.

Resolved—That the House will, to-morrow, again resolve itself into the said Committee.
