- The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr Speaker took the Chair, and read Prayers.
- 2. Ministerial Statement—Uniform Taxation Schedules.—Mr. Earle Page (Treasurer), by leave, made a Ministerial Statement with reference to the abolition of the duplication of Taxation Schedules, and the proposed adoption by the Commonwealth and the States of a uniform Schedule.
- 3. Paper.—The following Paper was presented, pursuant to Statute—
 Audit Act—Transfers of Amounts approved by the Governor-General in Council—Financial
 Year 1922-23—Dated 11th July, 1923.
- 4. "Hansard"—Authorization of Publication.—The Order of the Day having been read for the resumption of the debate on the following motion of Sir Elliot Johnson:—That, in the opinion of this House, with a view to removing the uncertainty which exists at the present time as to the authority for the publication of the Parliamentary Hansard, section 3 of the Parliamentary Papers Act should be amended to include Hansard among the documents authorized by Parliament to be printed and published—
 - Mr. W. Maloney, addressing the House, and not having concluded his speech, the House ordered that the honorable Member have leave to continue his speech when the debate is resumed.
 - Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for Thursday, 2nd August next.
- 5. Public Works Committee—Printing of Reports.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Gregory:—That the three Reports of the Public Works Committee, presented on 12th July, re certain works at Canberra, be printed—and on the Amendment moved thereto by Mr. Blakeley, viz.:—That the following words be added to the motion:—"and that the Minority Report (as regards the Provisional Parliament House) signed by Arthur Blakeley, member of the Public Works Committee, be also printed"—

6. NAVIGATION ACT—EFFECT ON TRADE—SELECT COMMITTEE.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Prowse:-That, in the opinion of this House, a Select Committee should be appointed to inquire into and report upon the effect of the operation of the Navigation Act upon Australian trade, industry, and development in the various States and Mandated Territories of the Commonwealth-

Debate resumed.

Question—put and passed.

Mr. Prowse moved, That such Committee consist of Mr. Josiah Francis, Mr. Albert Green, Mr. Lacey, Mr. Thomas Paterson, Mr. Seabrook, Mr. Watkins, and the Mover, five to form a quorum; with power to send for persons, papers, and records, to adjourn from place to place; and have leave to report from time to time its proceedings and the evidence taken; and that such Committee do report this day five months.

Debate ensued.

Mr. Anstey moved, as an amendment, That the name "Mr. Watkins" be omitted, and that the name "Mr. Edward Riley" be inserted in place thereof.

Amendment agreed to.

- Question-That such Committee consist of Mr. Josiah Francis, Mr. Albert Green, Mr. Lacey, Mr. Thomas Paterson, Mr. Edward Riley, Mr. Seabrook, and the Mover, five to form a quorum; with power to send for persons, papers and records, and to adjourn from place to place; and have leave to report from time to time its proceedings and the evidence taken; and that such Committee do report this day five months—put and passed.
- 7. SHIPPING SERVICE—MELBOURNE AND HOBART—SELECT COMMITTEE.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. O'Keefe: -That a Select Committee be appointed to inquire into the necessity for the Commonwealth Government making provision for an adequate direct shipping service between Melbourne and Hobart-Debate resumed.
 - Mr. Austin Chapman (Minister for Trade and Customs) addressing the House, and not having concluded his speech, the House ordered that the honorable Member have leave to continue his speech when the debate is resumed.
 - Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for Thursday next.
- 8. Postponement of Notice of Motion.—Ordered, That the consideration of Notice of Motion No. 1, General Business, be postponed until Thursday, 9th August next.
- 9. General Elections—Time for holding to suit Country Electors.—Mr. Lister moved, pursuant to notice, amended by leave, That, in the opinion of this House, in order to meet the convenience of electors in the country districts, it is desirable that, whenever possible, Commonwealth general elections should not be held during the period from November to February, inclusive. Debate ensued.

Question—put and passed.

- 10. CONTRACT SYSTEM FOR GOVERNMENT WORK .- Mr. Killen moved, pursuant to notice, That, in the opinion of this House, all Government work should, as far as possible, be carried out by contract.
 - Mr. Fenton addressing the House, and not having concluded his speech, the House ordered that the honorable Member have leave to continue his speech when the debate is resumed. Ordered—That the debate be now adjourned, and that the resumption of the debate be made an
 - Order of the Day for Thursday next.
- 11. Public Works Committee—Reference of Works—Shipping Facilities, &c., and Oil Depots, DARWIN.—Mr. Stewart (Minister for Works and Railways) moved, pursuant to notice, That, accordance with the provisions of the Commonwealth Public Works Committee Act 1913-1921, the following works be referred to the Committee for investigation and report, viz.:-
 - (1) Wharfage accommodation and shipping facilities, including sheds, railway and vehicle approaches, &c., Darwin.

(2) Establishment of oil depôts, Darwin.

- Mr. Stewart having laid on the Table plans, &c., and a Report by Engineer Vice-Admiral Sir William Clarkson, in connexion with the proposed works-Question—put and passed.
- 12. AIR DEFENCE BILL.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

And so it was negatived.

Mr. Bowden (Minister for Defence) moved, as a further amendment, That the following sub-clause be added to the clause:—

(2.) For the purposes of this Act, a person subject to this Act shall be deemed to be on active service whenever he is attached to or forms part of a force which is engaged in operations against the enemy, or is engaged in warlike operations in a country or place wholly or partly occupied by an enemy, or is in military occupation of any foreign country.

Debate ensued.

Amendment, by leave, temporarily withdrawn.

Mr. Charlton moved, as a further amendment, That the definition of "Air Force Act", (page 2, lines 3-5) be omitted.

Debate ensued.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Robert Cook reported accordingly.

Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

13. ADJOURNMENT.—Mr. Bruce (Prime Minister) moved, That the House do now adjourn. Question—put and passed.

And then the House, at six minutes to eleven o'clock p.m., adjourned until to-morrow at eleven o'clock a.m.
