- 2. Leave of Absence to Members (Sir Littleton Groom, Mr. Charlton, and Mr. Latham).—
  Mr. Bruce (Prime Minister) moved, by leave, That leave of absence for two months be given to the honorable Member for Darling Downs (Sir Littleton Groom), and to the honorable Member for Hunter (Mr. Charlton), on the ground of urgent public business; and for one month to the honorable Member for Kooyong (Mr. Latham), on the ground of ill-health.

- 3. ALTERATION OF DAY OF NEXT MEETING.—Mr. Bruce (Prime Minister) moved, That the House, at its rising, adjourn until Tuesday next at three o'clock p.m. Question—put and passed.
- 4. Message from the Senate.—Loan Bill (No. 2) (1924) [£6,450,000].—Mr. Speaker announced the receipt of the following Message from the Senate:—
