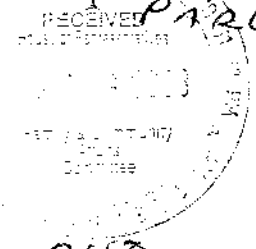
I HAVE CONSIDERABLE EXPERIENCE WITH FAMILY COURT MATTERS. P 1 of 11
