Dear Ms. Bishop,

Please find enclosed the DVD copy of the video provided by The Coalition Against Drugs (WA) at the Standing Committee Hearing, Perth 14th March 2007 for Hansard Records; (a) the 1992 US Presentation Speeches for the international drug legalization group, the US Drug Policy Foundation, (b) where Bill Stronach, Dr Alex Wodak and Dr Stephen Mugford are today, especially in regard to their drug legalization politics and (c) their official capacity which benefits and provides fundamental socialistic ideology to usurp The 3 International Conventions on Drugs under the auspices of the United Nations, signed and ratified by Australia, in 1961, 1971 and 1988.

1. Wodak, President of The Australian Drug Law Reform Foundation, key adviser to the Senlis Council and the International Harm Reduction Journal.
2. Stronach, Chief Executive Officer of the Australian Drug Foundation (ADF) and the President of the International Harm Reduction Association (IHRA). The ADF is funded by the Commonwealth Australian Drug Information Network (ADIN); IHRA is underwritten by George Soros through the Drug Policy Alliance (DPA). NB: A4 Speech extract from the DVD in print; info re DPA and its legalization advocacy and funding throughout the world. Soros funds to Stronach via IHRA (Melbourne), networks the Harm Reduction groups throughout the world.
3. Mugford, Responsible for the Evaluation of the NDS Framework 1998/99-2003/04 and QSR. Principal adviser to a variety of Commonwealth, State and Territory agencies. NB: *"Tough love at military clinic"* – Copy from the West Australian, 11/6/2005.

Dr Mugford with 6 other social science academics was commissioned and paid by the Commonwealth DOHA and the Inter Governmental Committee on Drugs under then Parliamentary Secretary to Tony Abbott, the Hon Trish Worth to evaluate the National Drug Strategic Framework (NDSF).¹ It is the practice of the Dept. of Health and Ageing/NDS Secretariat to evaluate itself by its academic peer advisers and allies for Harm Reduction/Drug Law Reform.

We trust that the Standing Committee members will achieve a clear perception and insight into the extraordinary propaganda and reprehensible methods by civil libertarians, social science academics, public health bureaucrats and the Australian Parliamentary Group for Drug Law Reform. NIDS has been infiltrated and usurped by the drug legalization movement masquerading as Harm Reductionists with the professed aim of only “minimizing the harmful effects of drug use in Australian society”.² Harm Reduction is the Trojan Horse and pre-cursor to drug legalization.

Indisputably, several government sectors, the Australian National Council on Drugs and an overwhelming and amorphous surplus of Think Tank Committees and Working Parties on Illicit Drugs must be held open to rigorous and independent accountability to assess if the Commonwealth has been defrauded, why Australia is swamped in illicit drugs which cannot be reduced and if financial or political advantage by deception has been provided by bureaucrats for the abolition of Australian Prohibition led primarily and covertly by Stronach, Wodak, Mugford and Hamilton.

Building Partnerships presented a so-called “shared vision and a basis for coordinated action”. Under the 1997-2009 NIDS, “Harm Minimisation refers to policies and programs designed to reduce drug-related harm and encompass a wide range of approaches”. According to Stronach’s Success Works P/L, “The NDSF maintained the focus on Harm Minimisation, which has formed the basis of Australia’s NIDS since 1985.”


