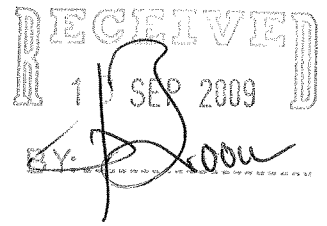

ON TAXATION.

DEAR SIRs.


IT IS THE SUBMISSION OF THE EXECUTIVE THAT THESE TREATIES NOT BE RATIFIED.  
IT IS OUR POLICY NOT TO SUPPORT ANY TREATY WHICH ALLOWS ANYONE TO AVOID  
TAXATION. ALSO AS THE AUSTRALIAN TAX OFFICE IS NOT A LEGAL ENTITY IT CANNOT  
BE PARTY TO A TREATY. AS STATED IN PREVIOUS TREATY SUBMISSIONS WE BELIEVE  
THAT ALL TAXES SHOULD BE COLLECTED BY TREASURY, A ONE PER CENT DEBIT TAX  
ON ALL TRANSACTIONS, ABOLISH THE TAX OFFICE, THE RESERVE BANK AND ALL OTHER  
TAXES. THE REASON THIS COUNTRY HAS FINANCIAL PROBLEMS IS BAD MANAGEMENT AT  
THE TOP. FOREIGN AID SHOULD CEASE ALSO FOREIGN DEBT PAYMENTS, THE PRACTICE
