DEAR SIRS.


IT IS THE SUBMISSION OF THE EXECUTIVE THAT THESE TREATIES NOT BE RATIFIED. IT IS OUR POLICY NOT TO SUPPORT ANY TREATY WHICH ALLOWS ANYONE TO AVOID TAXATION. ALSO AS THE AUSTRALIAN TAX OFFICE IS NOT A LEGAL ENTITY IT CANNOT BE PARTY TO A TREATY. THE CONSTITUTION FORBIDS ANY ONE OTHER TO COLLECT TAXES, YET THIS TREATY SPEAKS OF STATE TAXES. TO DISOBEY THE CONSTITUTION IS TREASON. THAT IS AN AMMENDMENT TO SECTION 24AA FEDERAL CRIMES ACT. 9<sup>TH</sup> JULY 2008. IS THE PARLIAMENT NOW SAYING THAT THEY CAN DISOBEY THE CONSTITUTION THE AUSTRALIAN CONSTITUTION IS A SELF GOVERNING DOCUMENT AND CANNOT BE OVERRIDDEN. THE COURTS ARE ABOVE THE PARLIAMENT, THE CONSTITUTION IS ABOVE THE COURTS. ACCORDING TO MOELIKER .V. CHAPMAN HCA. RULING THE HIGH COURT OF AUSTRALIA RULED THAT THE AUSTRALIAN TAX OFFICE NOT TO BE A LEGAL ENTITY. I TAKE IT THAT THE PARLIAMENT IS IN BREACH OF SECTION 25. 1903 JUDICARY ACT, IS IT POSSIBLE FOR THE PARLIAMENT TO DISOBEY THE CONSTITUTION, NO, IS IT POSSIBLE TO DISOBEY FEDERAL LAW, NO. THE LOWER TAX SCHEDULES IN JERSEY DEPRIVE OTHER AUSTRALIANS FROM ENJOYING THE SAME BENEFITS, THAT IS A BREACH OF THE FEDERAL CONSTITUTION.
