JOINT STANDING COMMITTEE

RE: TREATY BETWEEN AUST.&  
FINLAND . TAXATION.

DEAR SIRs.

IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY NOT BE RATIFIED. THE EXECUTIVE DOES NOT SUPPORT THE CONCEPT OF TAX AVOIDANCE BY ANY PERSON OR CORPORATION UNDER THE GUISE OF OVERLAPPING TAXING JURISDICTIONS. MULTINATIONALS AVOID TAX IN AUSTRALIA ON PROFITS. THE AUSTRALIAN PATRIOT MOVEMENT NATIONAL EXECUTIVE BELIEVE IN A DEBIT TAX OF ONE PER CENT ON INVESTMENTS TO SET UP , A ONE PER CENT TAX ON OPERATIONS IN AUSTRALIA AND A ONE PER CENT TAX ON PROFITS . MULTINATIONALS TAKE \$ 35 . BILLION FROM AUSTRALIA IN PROFITS WITHOUT TAXATION . THIS EXECUTIVE BELIEVE THAT COMPANY TAX SHOULD BE PAID ON ALL PROFITS, AND THAT TREATIES SUCH AS THIS TREATY SHOULD NOT BE USED BY ANY MULTINATIONAL TO AVOID TAXATION. THIS EXECUTIVE IS NOT ANTI-MULTINATIONAL , WE ARE CONCERNED AT THE PRACTICES OF THESE GROUPS IN RELATION TO TAX AVOIDANCE AND POLLUTION OF OUR PLANET. ARTICLE 26 . OF THIS TREATY STATES THAT OBLIGATIONS TO



COLLECT TAXES OWED TO OTHER PARTIES IS NOT ABSOLUTE BUT SUBJECT TO CERTAIN CONDITIONS AND LIMITATIONS. A FUTURE PATRIOT LED PARLIAMENT WILL ENSURE THAT NO ONE OR MULTINATIONAL WILL AVOID TAXATION. THIS EXECUTIVE IS CURRENTLY BUILDING A POLITICAL PARTY KNOWN AS THE AUSTRALIAN PATRIOT PARTY, IT WILL BE THE POLITICAL ARM OF THE NATIONAL EXECUTIVE. A ONE PER CENT DEBIT TAX WILL BE IMPOSED ON ALL FINANCIAL TRANSACTIONS, THE TREASURY WILL COLLECT ALL THE MONIES VIA AN ELECTRONIC DATA BASE ACCOUNT. THE AUSTRALIAN TAXATION OFFICE WILL BE ABOLISHED, ALONG WITH ALL STATE PARLIAMENTS, LOCAL GOVERNMENT, AND ALL LAW WILL BECOME FEDERAL LAW. ALL FOREIGN OWNED ASSETS WILL BE PLACED UNDER CONTROL OF THE FOREIGN AFFAIRS DEPT. THERE IS NO NEED FOR STATES TO BE REPRESENTED BY PARLIAMENTS, THIS FISCAL MISMANAGEMENT OF AUSTRALIA. IT HAS COME TO THE ATTENTION OF THIS EXECUTIVE VIA A DOCUMENT FROM THE (ATO) AUSTRALIAN TAXATION OFFICE, THAT THEY ADMIT THAT THEY ARE NOT A LEGAL ENTITY. HOW CAN A FEDERAL BODY WHO ACT A COLLECTOR NOT BE A LEGAL ENTITY UNDER LAW. THE OPPOSITE OF LEGAL IS ILLEGAL. FURTHER MORE ALL BANKS, BOTH DOMESTIC AND FOREIGN WILL BE PLACED UNDER STRICT CONTROL AND SUBJECT TO FEDERAL LAW IN RELATION TO BANKING PRACTICES CURRENTLY USED. THE POSITION OF OUR AUSTRALIAN RESERVE BANK WILL CHANGE, AS IT IS A PRIVATE COMPANY AT PRESENT, IT WILL BECOME A FEDERAL DEPT. ALL MONIES HELD BY THE RESERVE WILL BE UNDER TREASURY CONTROL, THE POSITION OF RESERVE BANK GOVERNOR WILL CEASE, AND THE FEDERAL TREASURER WILL BE INSTALLED AS CHAIRPERSON. ALL FOREIGN AID WILL CEASE, FOREIGN DEBT PAYMENTS WILL CEASE, BECAUSE THERE IS NO REAL FOREIGN DEBT, IT IS A PAPER TIGER. FINANCIAL MISMANAGEMENT WILL CEASE, ALONG WITH ALL UNEMPLOYMENT, POVERTY. THE REASONS WE ARE BECOMING A POOR NATION IS THAT OUR ECONOMY IS HANDLED BY PEOPLE WHO HAVE SELF FIRST, AND AUSTRALIA NEXT. THE AUSTRALIAN PATRIOT MOVEMENT IS BASED ON PATRIOTISM FIRST, SECOND AND THIRD. WE THE GREATEST RACE OF PEOPLE ON EARTH, IN THE GREATEST NATION ON
