SECTION 6 SPEAKS OF THE RULE OF LAW BEING AT RISK, THIS EXECUTIVE IS FIGHTING THROUGH THE COURT SYSTEM AT PRESENT ON CONSTITUTIONAL MATTERS, THAT THE COURTS IGNORE, THE RULE OF FEDERAL AND CONSTITUTIONAL, PLUS INTERNATIONAL LAW.

THE STATE PARLIAMENTS IGNORE STATUTE LAW DAILY, THIS IS A FORM OF CORRUPTION, YET NOTHING IS DONE, FEDERAL REFERENDUM RESULTS ARE ALSO IGNORED BY STATE PARLIAMENTS, AND COURTS.

THE CHARGING OF LAND RATES, IN ALL STATES CONTRAVENES HIGH COURT RULINGS, SECTION 25, 1903 JUDICARY ACT. AND THE 1988 FEDERAL REFERENDUM.

THIS IS CORRUPTION, THE EXECUTIVE CALL ON THE PARLIAMENT DO INTERVENE ON CORRUPT BEHAVIOUR BY OUR STATE PARLIAMENTS AND STATE COURTS IN CONTRAVENTION OF THE GOVERNMENTS (THE PEOPLE) WISHES.

IN A DEMOCRACY ALL THE PEOPLE ARE THE GOVERNMENT, NOT THE PARLIAMENTS, THE PEOPLES WILL MUST BE OBEYED.


ARTICLE 27, OF THIS TREATY REQUIRES THE PARLIAMENT TO MAKE IT A CRIMINAL OFFENCE TO CONTRAVENE THIS CONVENTION.
