I wish to express grave concern, or rather *alarm* at what I see happening in Australia with regard to the influx of powerfully motivated Islamic elements within the general group of migrants.

Whilst I heartily endorse migration on the whole i.e. hardworking, skilled people who are able and willing to integrate whilst respectfully holding on to their individuality, customs and beliefs. The large contribution they have and are still making, is indeed a credit to them.

I refer rather to the extremist elements whose expectations, indeed *demands*, and imposition of values and Shariah law which they deem to be superior, and threaten with malintent if their demands are not met. This surely must be stopped whilst we still can. There is no longer room for complacency or appeasement. It will not go away as is well evident all through Europe and beyond, rapidly proliferating now also in America.

Incidents abound. Crime is on the increase directly related, I believe, to the misplaced feelings of superiority, ignorance and the conviction of Islam being the only religion to follow, not to mention their treatment of women.

The acquiescence of moderate Muslims does not help...be it as a result of intimidation or underlying loyalty and support of their 'brothers'. 'Double-speak' also comes naturally to them since the Quran clearly states that it is perfectly permissible to deceive if it serves the Muslim cause.

With indoctrination from a very early age of hatred against the non believers, all of whom are considered, infidels....I find it significant that their presence is already so strongly felt despite it being as yet only 2% of the Australian population. Hatred is deeply ingrained in their psyche.

Islamisation creeps in almost imperceptibly with well thought out strategies as is witnessed for example, in the ploy of hallal practice. Whilst Sharia-compliant certified meat is neither leaner nor of greater nutritional value, it is about antiquated religious rituals which take place as the animal is slaughtered.

Nearly two thirds of all chicken and lamb and almost half of the beef in Australia is now sold as hallal-certified by abattoirs and processing plants, yet the Muslim population as mentioned above constitutes only 2% in Australia. Fees are charged to the certified companies at time of issue and for each renewal generating much revenue. Immigrant Muslims are able to create a demand by entering the country as ritual 'slaughterers' by 'profession'.

These extra costs are recovered from consumers who unknowingly pay extra for Hallal-certified products from companies and manufacturers. Often there is no labelling to indicate this ritual slaughter or hallal certification. This omission means that the Australian public is denied freedom of choice in what they purchase. They may

neither require nor wish to pay extra for products secretly sold to them, simply to generate extra funds for Muslim causes. Australian meat has been exported overseas for decades prior to self-appointed Islamic Hallal 'authorities' whose notorious schemes result in Australians actually paying for the Islamisation of our own country.

The irony is that there is actually no requirement in the Quran which demands Muslims having to eat Hallal-certified meat.

Quran Sura 2:173 (Al-Baqarah) reads: "*He hath forbidden you only carrion, and blood, and swine flesh, and that which*

*hath been immolated to any other than God.*" Also, there is the Hadith narrated by Aisha (Bukhari Volume 3, Book 34,

Number 263) where Muslims are told: "*Some meat is brought to us by some people and we are not sure whether the name*

*of Allah has been mentioned on it or not.*" Allah's Apostle said: "*Mention the name of Allah and eat it.*"

Most observant Muslims are fully aware of Australian beef, chicken, lamb and goat being totally permissible for them to

eat, and has always been so. Therefore the integrity of this hallal scheme must be seriously questioned and recognised

for what it is, an enormously profitable commercial venture to further Islamic causes....with all that extra revenue going to questionable sources.

I have honed in on only ONE aspect of many reservations I regretfully have regarding permission granted to ANY more Muslims into this wonderful country of ours.
