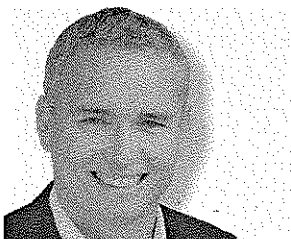
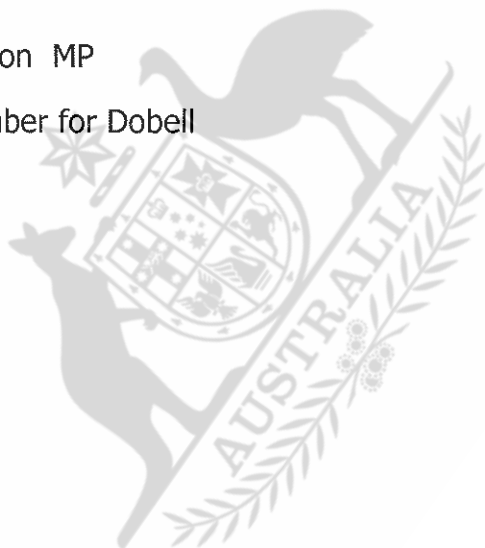
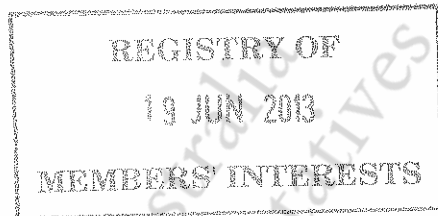
A bank account held in trust by a Mr Worthington and a Mr Allan to which members of the public can donate money to assist me with my legal fees has been established.
