My basic interpretations of access;

- 1: A father who is a non-resident parent of a child under 1 year of age be given full access on a daily basis in short intervals at a time when the child/baby is awake, this time to be decided in mediation which is arranged through lawyers and a mediation company,
- 2: A father who is a non-resident parent of a child at the age and from the age of 1 year and after doing said number of hours at parenting school be given automatically 50% access decided through lawyers and mediation based on per week or per day if both parents live close to each other,
- 3: A non-resident parent who has lived with their child for at least the first two years of the child life be given automatic 50% access without requirements.
- 4: grandparents of non-resident parent have the same access arrangements to said child even and especially if the non-resident parent cant execute their right to access
- 5: On and only on medical proof can access be denied weather that be the child be sick or extreme special circumstances such as special needs or proven risk to said child of sexual abuse and or if the failure of nonresident to comply with requests of anger management but only after proof has been shown of anger management needed
- 6: All non-resident parents families such as aunties and uncles been given the opportunity to gain access to be agreed in mediation in such cases that a non-resident parent is diseased the Auntie be given the same right unless proof is able to be shown of threat
- 7: The day-to-day resposibiltys are shared as custody dictates
- 8: The name be shared equal in all portions with hyphenated name
- 9: If the nonresident parent doesn't wish to exercise their right to 50% access than a percentage of net income is payable, agreed to by the lawyers and inforced the same as a driving fine or similar
- 10: If the mother doesn't wish to exercise her right to 50% access of said child she then agrees to pay said amount of net pay
- 11: In the event of a matter having to go to court to be disputed in-regards to child safety the government allocated the sum of \$5000.00 per party for legal expense
- 12: In the event that a Childs parent has a passport to a forien land that does not have extradition treaty then passport be surrender to the lawyer of the opposite side
- 13: Both parties to equally share costs of Childs living if 50-50 access is retained
- 14: either parent be given the same amount of time with child on birthdays Christmas etc
- 15: If one parent moves away from the other travel times must be agreed to and the party who has moved must do the majority of travel
- 16: The parent who moves away must accommodate school requirements for child in accordance with 15 above
- 17: Both parents use a records book to track movements and activities of child under their care this book will travel with child; breech of book can result in court case
- 18: All medical transactions that take place with said child be accompanying of said book at all times

Dear Ray, ive watched your shows over the last couple of months with great interest in regards to the injustices that males are going through in the courts .Please dont think for a second that i believe that all males who go through the system are good dads and that all dads are victims. I also sympathise with females who also suffer because of the system ,the most important part of the whole process is the children..You have shown various aspects to the wide and varied cases presented to you.Unfortunately the media in general has an under linedbelief of selling what there offering for the greater benefit of the thing that makes society go-round (money).I would like to ask you to do a sum-what indepth show ,a special perhapes, that covers the history of the equal oppurtunities rulings in the courts ,my piont is to find out openly and on tv why such rulings where made some 40 years ago yet the family court doesnt acknowledge those rulings and apply them in there own court. I also would like you to investegate the forms of child abuse and the extent to which they inflict on the children ,the reason i mention this is i have worked with abused children and at this piont , more importantly profesionals whom deal with the children on a day to day basis ,(there is a saying ive heard many times "the priests were bad but the nuns were worse" ,it comes from the children who are now in there 50-60's and who were raised in orphanages)beleive that the greatest form of child abuse is mentel abuse ,and the greatest contributors of that abuse is from females ,mostly single females ,most of the children go untreated because the bruises are self inflicted by the children as they go through life beleiveing that there worthless or stupid etc.I have shed many teerslistening to the stories of abuse that some children have had to deal with.But one thing i cant except is that i should be blamed or made to feal as though i had committed those crimes because i was walking into a court fighting for my childs right to have his dad in his life and my x developed a hatred for me because (i believe) her hormones went of the chart.There wasnt any domestic violence or abuse (other than the normal break down emotions)She knew the system, i didnt she set me up all she wanted was another child ,and she got one ,i believed she loved me.She made false acusations against me about my mentel state in an attempt to get soul custody,the court did nothing when they found out if her accusations werent true ,she was found guilty of contempt of court in another apperence and the court still did nothing.Now,over a year and a half later my access to my child is two and a half hours per fortnight, what i find most insulting is the court has aloud her to dictate the final orders that i have to live with ,i ve been offered extenstions to my time then the offers have been withdrawn by her(teaseing me) the lawyers wont take her back to court because ,and i have been told by two different law firms on two seperate occasions that i wont win because im male.I would like you to investegate the money the government gives to mothers to take the matters to court ,as my x was given \$10,000 worth of legel representations in court. When i suffered a work place injury and ended up unemployed i asked for legel representation in court i was told i could only get advise and if i wanted a lawyer id have to find the means ,on this piont i was lucky i had good credit but what about the dads who dont have assets or high paying jobs ,only 1.5% of fathers contest access after what youve just read do you blame them???Given the fact that equal rights laws came into place 40 or so years ago i cant figure out why males dont have equal rights in there own homes ,could it be that more than 50% of domestic violence happens in the last days of a relationship when the male knows the road that the female is about to walk down is more or less no go zone if he wants to keep his self respect and any money he may have left after ,if she kicks him out ,he loses his funiture that he might have collected, his house if he respectshis children (or if he isnt a so called a-hole)I watched your show show stories of of males killing there children , ive also scene females killing ther children males and females abuseing children the courtin victoria only have three judges to decide all the cases that go before them,surely we come back to the chicken and the egg sindrome not all mothers are good for there children yet even if a dad is a good dad the courts wont acknowledge them the court doesnt acknowledge the vindictive nature that some women have towards males.Fe males arent always the victims ,and once again what about the grandparents of the males who miss out completely, the government and the courts would rather see children spending all day in day care rather than allowing dads and there familys have any involvement during the week ,have you spoken to the adults that have gown up without their dads because i have ,the courts are sexually discrimanating against males because they havent got the resourses to cope ,eventually enough people will get together and form a law suit against the government (past and present)and the family court .Have you investagated the amount of money that the legel firms would lose if equal opportunity became law equal access with mediation that both parents pay for , all the lawyers would do would be to right agreements between each party ,i wonder if the government is reluctant to give equal rights because alot of dads would take up there right to father their own children and they would go on pensions and alot of skilled workers would leave full time employment and go to part time employment ,child support would deminish to next to nothing ,the government would lose the interest on the money thats generated weekly ,i now suppose thats why it can take up to three months for money to change hands from dads to mums.Id ask you this given the situation you are extensively coverying in Qld about the ten children and the government refusing to help,id ask you why would the government care

about all the other children on the earth, the answer is they dont so why are they implementing laws that go against the very basic of human right,laws that were not only decided by the supreme court 40 years ago but are part of what we call basic human rights in a democratic country like Australia,why is the government ruling over, say, my case?????what possible interest do the government have with how much time i spend with my child , the government is happy enough to lock children up in detention centres rather than addressing some of the most basic of destresses that children display ,sometimes all they want is their parents but because mum was a bitch and verbally bashed dad year after year and he finally couldnt take the stresses of life so he killed himself, unfortunately the courts dont acknowledge that being verbally day after day causes people to snap ,theylash out sometimes its violence sometimes drugs sometimes their downhill spiral may only take one day from snapping to sitting pissed in a car with a hose in the window unfortunately worse when they kill their children.....Your a very well respected journalist ,only a proper storie will correctthe wrongs and stop most of the blood being spilt PLEASE many regards Giles
