**SPECIFICATION OF MIGRATION OCCUPATIONS IN DEMAND FOR THE  
PURPOSES OF REGULATION 1.03**

I, PHILIP RUDDOCK, Minister for Immigration and Multicultural and Indigenous Affairs, acting under regulations 1.17 and 1.03 of the Migration Regulations 1994 ("the Regulations"), hereby:

- (1) REVOKE the gazette notice specifying skilled occupations as migration occupations in demand for the purposes of the definition of "migration occupation in demand" in regulation 1.03 of the Regulations signed on 28 April 2001; and
- (2) SPECIFY each skilled occupation referred to in the Schedule as a migration occupation in demand for the purposes of the definition of "migration occupation in demand" in regulation 1.03 of the Regulations.

[NOTES. (1) Regulation 1.17 of the Migration Regulations provides that the Minister may, by notice published in the Gazette, specify matters required by individual provisions of the Regulations to be specified for the purposes of those provisions.

(2) Regulation 1.03 provides that a migration occupation in demand means a skilled occupation that is specified by Gazette Notice as a migration occupation in demand.]
