My solicitor has openly told me even when we go to court and get orders in favour of contact that my ex-wife and boyfriend will continue their games.\*\*\* THESE PEOPLE HAVE NO RESPECT FOR THE LAW AND MY SON IS LIVING UNDER THEIR CARE AS I DON'T HAVE THE MONEY TO PROVE THAT HIS CURRENT GUARDIANS ARE NOT A GOOD ROLE MODEL. THE LAST TWO YEARS OF MY LIFE HAVE BEEN HELL I REALLY DO NOT BLAME SINGLE PARENTS FOR ENDING WHAT SEEMS TO BE A HOPELESS SITUATION WHEN IT COMES TO CONTACT AND RESIDENCY OF THE MOST LOVED INDIVIDUALS IN THEIR LIFE.

I AM NOW IN A STABLE FUNCTIONAL RELATIONSHIP FEELING VERY LUCKY TO HAVE FOUND SOMEBODY SO SPECIAL,BUT I AM AXIOUS AND AFRAID THAT THESE DISFUNCTIONAL PEOPLE WILL NOT STOP FOR ANYTHING AND FURTHER MORE PUT



MY LIFE IN DANGER.ADDING TO THIS I FEAR FOR MORE GIRLFRIEND AND DAUGHTER.

IS THIS HOW THE LAW IS WRITTEN-"TO PROTECT THE CRIMINAL MINDED PEOPLE WHO KNOW THE SYSTEM SO.....WELL THAT THEY CAN PROLONG A NATURAL FATHER FROM HIS RIGHTS TO SEE HIS LITTLE BOY GROW UP?
