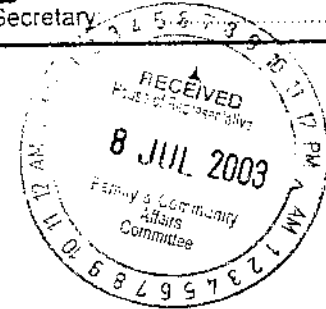

Subject: Being a Father

To whom It May Concern;

I've been trying to be a Father for the last 15 years on my terms in Australia-after emmigrating here in 1989 and have been totally alienated from my Son by my Ex.
