RE.TREATY ON PLANT
GENETIC RESOURCES.

DEAR SIRs.

IT IS THE SUBMISSION OF THIS EXECUTIVE
THAT THIS TREATY SHOULD NOT BE RATIFIED, ON POSSIBLE
FUTURE LEGAL GROUNDS, ALSO OFFENCES UNDER INTERNATIONAL

OBLIGATIONS LAYED OUT THAT REQUIRE AUSTRALIA TO PROVIDE THE APPROPRIATE PGRFA, IN THE CASES OF AN EMERGENCY DISASTER IS TO US A FUTURE TRIGGER FOR FULL CONTROL.

THE INVOLVEMENT OF FUTURE COSTS TO AUSTRALIA TO SUPPORT INTERNATIONAL SECRETARIAT ACTIVITIES IS TO THIS EXECUTIVE UNACCEPTABLE ALSO.

THE SECTION CONCERNING FARMING RIGHTS, BIG DEAL. FARMERS IN AUSTRALIA HAVE PROBLEMS ALREADY WITH DROUGHTS, THE HIGH COSTS FROM GREEDY BANKS, UNCARING POLITICANS, NOW THESE ONE WORLD GOVERNMENT PEOPLE TALK ABOUT GIVING THEM RIGHTS. THAT IS AN INSULT.
