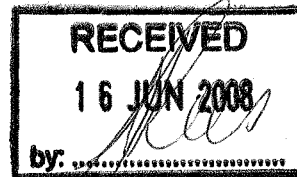

UNITED NATIONS CONVENTION
RIGHTS OF PEOPLE WITH DISABILITIES.

DEAR SIRs.

IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY BE RATIFIED, IT IS THE BELIEF OF THE AUSTRALIAN PATRIOT MOVEMENT NATIONAL EXECUTIVE THAT NOT ENOUGH IS BEING DONE TO ASSIST PEOPLE WITH DISABILITIES . AFFORDABLE HOUSING FOR THE DISABLE SHOULD BECOME A MAJOR TASK OF THE PARLIAMENT, ALSO AFFORDABLE HEALTH , SHELTERS FOR THE HOMELESS , MANY WHO SUFFER FROM DISABILITIES . THERE IS NO POINT HAVING AN INTERNATIONAL AGREEMENT IN PLACE UNLESS THE MONEY AND SKILLS ARE NOT IN PLACE . THE EXECUTIVE DO NOT WANT TO SEE ONLY A TOKEN EFFORT , BUT INSTEAD A MAJOR COMMITMENT BY THE LABOR PARLIAMENT IN RELATION TO THIS SERIOUS MATTER. THERE IS NO POINT BY CREATING JOBS FOR THE DISABLE , WITHOUT HOUSING , DECENT PENSIONS , AND MORE AFFORDABLE HEALTH SERVICES , I MYSELF RECEIVE A DISABILITY PENSION, I FIND IT HARD TO SURVIVE . THE EXECUTIVE CALL ON THE PARLIAMENT TO HOLD A NATIONAL INQUIRY INTO THE ASSISTANCE OF PEOPLE WHO ARE DISABLE . I WOULD PUT MY NAME FORWARD TO PROVIDE INPUT INTO SUCH AN INQUIRY , ON BEHALF OF THE DISABLE. THE MENTAL HEALTH SYSTEM IS IN TATTERS , PEOPLE ARE FORCED OUT OF INSTITUTIONS BY THE SYSTEM TO LIVE ON THE STREETS , AND TO BE AT THE MERCY OF CRIMINALS , IT IS TIME FOR THE SYSTEM TO POUR BILLIONS OF DOLLARS INTO PROTECTING THE POOR, DISABLE , HOMELESS , WHO MAKE UP A LARGE NUMBER OF AUSTRALIA , WE DO BELIEVE THAT THE KEVIN RUDD PARLIAMENT IS SERIOUS ABOUT THIS ISSUE , BUT IT REMAINS



TO BE SEEN IF WE ARE RIGHT, THE OVERVIEW STATES THAT PROGRAMS ARE IN PLACE THAT IS TRUE, BUT THE MONEY MUST BE INCREASED, AND A BIGGER EFFORT MADE BY THOSE WHO RUN THESE PROGRAMS, SUCH AS CENTRELINK, PAPERWORK IS DROWNING PEOPLE, ABORIGINAL EMERGENCY HOUSING PROGRAMS, ARE POORLY FUNDED, THERE IS NO EMERGENCY PROGRAMS WORTHWHILE FOR WHITE AUSTRALIANS, THE ABUSED FEMALES CAN GO TO SHELTERS, MANY MEN END UP HOMELESS BECAUSE OF MARRIAGES THAT FALL APART, THAT IS DISCRIMINATION, THE COST OF DISABILITIES IS DUE TO REGULATIONS BY THE PUBLIC SERVICE, ITS TIME TO REDUCE THE LEVEL OF PAPERWORK TO MAKE THE SYSTEM WORK. SECTION 16. STATES THAT WOMEN AND GIRLS HAVE SPECIAL PROBLEMS, TRUE, ALSO MEN WHO HAVE MENTAL OR RELATIONSHIP PROBLEMS, SEXIST STATEMENTS DOES NOT HELP ALL PEOPLE WHO HAVE DISABILITIES, THE STATEMENT THAT INTERNATIONAL LAW REQUIRES ALL PEOPLE BE TREATED EQUAL IS TRUE. IT IS TIME THAT THE PARLIAMENT STOP CATERING TO SPECIAL INTEREST GROUPS AND REPRESENTED ALL OF THE PEOPLE OF AUSTRALIA, WHO ARE THE GOVERNMENT, THIS EXECUTIVE IS THE VOICE OF THE GOVERNMENT (THE PEOPLE) UNDER INTERNATIONAL LAW.
