JOINT STANDING COMMITTEE

ON TREATIES .

RE: TREATY BETWEEN AUSTRALIA

AND NEW ZEALAND , ECONOMIC ZONE.

DEAR SIRs.

THIS EXECUTIVE WOULD NORMALLY SAID YES TO ANY TREATY INVOLVING OUR NIEGHBOUR , BUT WE HAVE SUCH A TREATY TO BE A CONSTITUTIONAL PROBLEM .

UNDER LAW WE HAVE BEEN TOLD THAT OFFICIALLY NEW ZEALAND IS STILL PART OF N.S.W. INFORMATION IS THAT IT TAKES THE SIGNATURE OF THE N.S.W. PREMIER TO RETURN NEW ZEALAND TO N.S.W. CONTROL . IF THIS IS THE CASE THEN A TREATY BETWEEN AUSTRALIA AND NEW ZEALAND WOULD BE ILLEGAL UNDER INTERNATIONAL LAW.

IT HAS ALSO BEEN MENTIONED TO THIS EXECUTIVE THAT THERE IS TWO SEATS IN FEDERAL PARLIAMENT SET ASIDE FOR THE TWO ISLANDS OF NEW ZEALAND REPRESENTATIVES .

COLONIAL LAW BECAME NUL AND VOID ON THE SIGNING OF THE TREATY OF PEACE , AT VERSAILLES . ( TREATY OF VERSAILLES ) 28<sup>TH</sup> JUNE 1919. HOWEVER BRITISH LAW REMAINS IN OUR COURTS , THIS IS A


VIOLATION OF INTERNATIONAL LAW , SIR WILLIAM MORRIS HUGHES DECLARED US A SOVEREIGN NATION 1<sup>ST</sup> OCTOBER 1919 , ( HANSARD 12163- 12179 ) SIR BILLY HUGHES WAS NOT ONLY THE PRIME MINISTER OF THE DAY , BUT ALSO FEDERAL ATTORNEY GENERAL.

INTERNATIONAL LAW HAS BEEN AND CONTINUES TO BE IGNORED , BY THE STATES . THIS EXECUTIVE SUPPORT FEDERAL LAW AND INTERNATIONAL LAW ONLY.

THE FEDERAL PARLIAMENT SHOULD INFORM THE STATES THAT ALL STATE LAW IS OVERRIDDEN BY FEDERAL LAW , INTERNATIONAL LAW , AND THE REAL GOVERNMENT , BEING THE AUSTRALIAN PEOPLE. IF NEW ZEALAND IS STILL PART OF N.S.W. THEN THE NEW ZEALAND PARLIAMENT IS ALSO ILLEGAL , AND CANNOT SIGN ANY TREATIES . ALL LAWS IN AUSTRALIA MUST BE IN ACCORDANCE WITH INTERNATIONAL OBLIGATIONS , AND TREATIES , TWO SOVEREIGNTIES CANNOT CO EXIST UNDER THE RULING BODY KNOWN AS INTERNATIONAL LAW . BRITISH LAW IS TOTALLY INVALID IN AUSTRALIA AND NEW ZEALAND .

THE EXECUTIVE WISH TO THANK THE COMMITTEE FOR ALLOWING US TO COMMENT ON THIS IMPORTANT TREATY PROPOSAL .
