RE: TREATY BETWEEN AUST. &  
THE SWISS CONFEDERATION  
ON SOCIAL SECURITY.

DEAR SIRs.

IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS NOT BE RATIFIED,  
AS WE DO NOT SUPPORT THE CONCEPT OF SOCIAL SECURITY BENEFITS  
OUTSIDE OF AUSTRALIA TO ANY PERSON.

IT IS OUR OPINION THAT ONCE A NATIONAL LEAVES AUSTRALIA THEN  
THEY ARE NO LONGER WANTING TO BE AUSTRALIAN ,IF THIS GREAT  
COUNTRY IS NOT GOOD ENOUGH TO LIVE IN , THEN THEY SHOULD NOT  
EXPECT ANY PAYMENTS FROM US. THE EXCHANGE RATE WOULD GIVE  
SOME NATIONALS A GREATER STANDARD OF LIVING TO THOSE PERSONS  
LIVING IN AUSTRALIA. ALSO THERE WOULD BE NO WAY OF PROVING  
THAT THESE PERSONS WERE NOT WORKING , OR CONDUCTING ANY KIND  
OF BUSINESS OVERSEAS WHILE RECEIVING SOCIAL SECURITY PAYMENTS,  
WE ALSO NOTE THAT THERE IS NO LONGER A DOLE PROGRAM BUT IT  
IS NOW CALLED WORK FOR DOLE , JOB SEARCH ALLOWANCE. HOW DO  
DO YOU LOOK FOR WORK IF YOU ABLE TO SIT IN A SWISS CHALET  
DRINKING COFFEE AT OUR EXPENSE .

TREATIES SUCH AS THIS ARE AN INSULT TO THOSE WHO ARE UNEMPLOYED HERE IN AUSTRALIA , THROUGH MISMANAGEMENT BY ALL STATE AND FEDERAL PARLIAMENTS SINCE THE END OF THE FIRST WORLD WAR. A FUTURE PATRIOT LED PARLIAMENT WOULD END ALL UNEMPLOYMENT , AND POVERTY WITHIN TWO WEEKS OF TAKING OVER CONTROL OF THIS NATION . THE EXECUTIVE WISH TO THANK THE COMMITTEE FOR ALLOWING US TO COMMENT ON THIS TREATY.
