## Melbourne visits for vocational education in schools inquiry

The rapidly growing area of vocational education and training (VET) in schools is being investigated by the House of Representatives Education and Training Committee.

On **Tuesday 2 September**, public hearings will be held in Melbourne with educators, community partners, independent schools and private training providers. Their submissions indicate the need for greater resourcing of the popular VET initiatives. See program over for more detail of organisations appearing.

On **Wednesday 3 September**, the Victorian Automobile Chamber of Commerce, EPIC Industry Training Board, and Light Manufacturing Training Australia, will all caution on the need for quality VET in school programs to ensure that VET qualifications maintain their credibility. Biotechnology, an identified growth industry, will be represented by AusBiotech and the Gene Technology Access Centre, and will outline their work in improving students' awareness of potential careers. On Wednesday afternoon the Education Committee will visit **Northland Secondary College** to talk to students and staff about their work in vocational education programs in schools, particularly support for indigenous students, design programs, the development of a new manufacturing technology centre, and community and industry support.

**BACKGROUND:** The inquiry is examining the range, structure, resourcing and delivery of vocational education and training programs in schools, including teacher training, the impact of vocational education on other programs, vocational education in new industries, and the accessibility and effectiveness of vocational education for indigenous students.

"Vocational education and training in schools is growing rapidly," says House Education Committee Chair, Mr Kerry Bartlett. "We need to be sure we are maximising its potential to support young people to choose effectively from the range of pathways available to them and to successfully make the transition from school to work or further education and training.

"Northern Melbourne has had high youth unemployment. We are interested in the effectiveness of vocational education in schools in preparing students for their future work life. We also need to identify the strengths of the Victorian system, how to support industry initiatives, while encouraging young people to complete Year 12. Other states are trialling the Local Learning and Employment Partnership model that was developed in Victoria, so it will be worthwhile to hear about the benefits of the system."
