you can you please explain and can we
look thru your BANK ACC I would have
given it AS I HAD NOTHING TO HIDE
BUT give THE PERSON THE RIGHT TO
DEFEND HIM OR HER SELF

CentraLink also knocked on my door with the same allegations some anonymous person had phoned up and said that I had 2 full time jobs. I had the investigator from CentraLink satisfied in such a way that there was no truth in the allegations as I already had 8 sworn affidavits by then to totally disprove the allegations. Now why couldn't workover have done the same instead of all the secrecy. It is not your innocent until proven guilty - but you're guilty and you prove you're innocent.

They also went to my doctor for medical records again without my knowledge. He just happened to mention it on one of my visits to him, again. What about Doctor - Patient Privilege as I had nothing to hide I faxed him a letter stating that he was to fully cooperate with them and that I would not hold anything against him. Again why was I not contacted first for permission. And what about my rights. I always thought that when a judge rules in a court case in your favour that is the end of it. But it seems they will just keep on trying till they find someone who will rule in their favour. It's not like Double-jeopardy.
