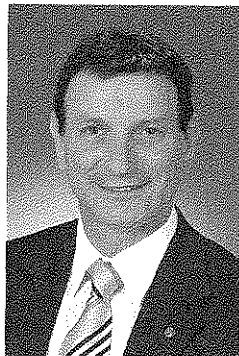

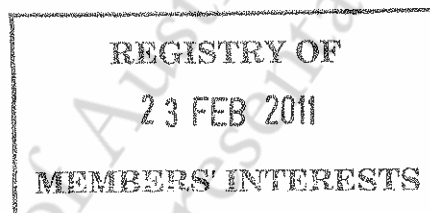

I write to update my entry in the Register of Members' Interests.

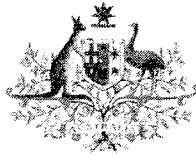
