Senator Siewert asked:

Could you provide information on which communities CatholicCare NT deliver support for, the number of people on the lands, and also the funding that is available for those services for 2010-11.

Also, are the same provisions being made for the next financial year or will funding be increased?

Could you also provide the community work that is done in each of those communities?

In addition, could you also include the 10 remote sites and the funding allocated to each of them?

Answer:

CatholicCare NT provides PHaMs services in Amata and outreach services in areas such as region (Kaltjiti) and Ernabella (Pukatja) in the APY Lands.

In 2006 the ABS identified that the APY Lands had 2,230 residents.

In 2010-11 CatholicCare NT has been funded \$644,500 for PHaMs services in the APY Lands. The same provisions have been made for the next financial year.

CatholicCare NT provides case management for the person with mental illness and their family, individual activities for recovery, group work with other members of the community and relationship building with other services. They also deliver a range of other culturally appropriate activities to promote wellbeing in the community such as:

- a music program run by an Anangu male;
- leatherwork for both male and female clients, drawing on the knowledge and skills of a male elder and young Anangu woman;
- activities for women both clients and carers; and
- supporting skills development.
