Senator Polley, Helen asked:

Please outline how the Agency engages with industry and the public. Be specific and outline the locations and types of engagements.

Answer:

The Quality Agency Annual Report 2013/14 states the level of engagement undertaken by the Chief Executive Officer and senior managers with the industry and the public. The information below is an excerpt from pages 31 to 33.

Also attached is a table outlining the Quality Agency engagements undertaken with industry and the public from 1 July 2014 to 28 February 2015 by the Chief Executive Officer and senior managers.

The Quality Agency engages with the public:

The public are able to download the latest report on homes on our website at http://www.aacqa.gov.au/site/pdfs/reports. A link to this page is available on our home page to make sure this page is easy to find for the public.

Between 1 July 2014 to 28 February 2015 over 13,000 reports on homes were downloaded. This page allows the public to find reports on homes using any search criteria such as state, suburb or entering the name of the home or partial name of a home. These reports on homes are used by the public as part of their process to find a suitable aged care home.

The Quality Agency website provides information to the public and between 1 July 2014 to 28 February 2015 was visited by over 75,000 people. Of these 56 per cent or 42,000 people visited the Quality Agency website more than once. During this period the public accessed our website using desktop (81 per cent), mobile (10 per cent) and tablet device (9 per cent). The average duration of visits on the website was over 3 minutes.

Our industry newsletter *Quality Standard* is distributed monthly and focuses strongly on promoting quality, research and evidence based practice, designed to highlight latest evidence in relation to aged care in Australia and internationally. There is also a focus on telling stories of how particular homes have implemented programs, to inspire and inform other homes.

Every month the *Quality Standard* is emailed to over 2,000 members of the public (4,300 monthly email total) and over 900 print copes (8,000 monthly print total) are sent to the public. In 2013/14 the Quality Standard was emailed to over 4,300. Copies of the Quality Standard are available on our website at http://www.aacqa.gov.au/about-us/the-standard.

The Quality Agency engages with industry:

"Stakeholders (taken from the Annual Report 2013/14)

The Quality Agency is committed to consultation with stakeholders, and contributing as a key participant in quality initiatives, industry forums and working groups.

Quality Agency management and staff participate in a number of industry committees and working groups as well as participate in Better Practice conferences as session chairs and speakers.

The Chief Executive Officer, General Managers and State Managers also attend and make presentations to industry conferences and at accreditation and safety and quality conferences. This enables them to meet with a range of stakeholders and obtain direct feedback regarding the Quality Agency and to gain a broader understanding of the issues facing the industry.

We also briefed a number of delegations from overseas.

The Chief Executive Officer has presented to a number of forums including national and state industry associations' conferences and the National Aged Care Alliance.

The State Managers chair each of the State Agency Liaison Groups. The liaison groups comprise representatives of industry associations, unions, and consumer groups and discuss industry trends and provide feedback.

Relationship managers (taken from the Annual Report 2013/14)

Relationship managers are appointed for larger approved providers, and for those providers whose operations cross state borders. The relationship manager is responsible for coordinating the overall relationship with the provider, and give internal advice on case management of the provider, and homes of the provider.

The relationship manager meets with the approved provider at least twice a year and acts as a central point for enquiries, service planning and contact for the provider in relation to all homes within the group."
