**Senator Brown** asked:

Will indexation be applied to all grants under each of the rounds in the 2014 DSS Grants rounds? If not which grants will not have indexation applied?

**Answer:**

Not all of the Department's spending activities have indexation applied.

Where indexation is applied, the appropriate Wage Cost Index or Consumer Price Index is determined at the budget measure level in the New Policy Proposal (NPP) Budget stage by the Department of Finance.

Each year indexation rates – and this financial year, pauses on indexation – are determined by Government at each Budget. There are 23 DSS programmes which are subject to the indexation pause (see Attachment A).

Indexation may be passed on to grant recipients at the rate at which it was received from Department of Finance on an annual basis, at the grant level.
