#### **Question:**

Since the change of Prime Minister on 14 September 2015:

- a) how often has each board met, break down by board name;
- b) what travel expenses have been incurred;
- c) what has been the average attendance at board meetings;
- d) list each member's attendance at meetings;
- e) how does the board deal with conflict of interest;
- f) what conflicts of interest have been registered;
- g) what remuneration has been provided to board members;
- h) how does the board dismiss board members who do not meet attendance standards;
- i) have any requests been made to ministers to dismiss board members;
- j) please list board members who have attended less than 51% of meetings; and
- k) what have been the catering costs for the board meetings held during this period? Please break down the cost list.

#### **Answer:**

In relation to the Welfare Payment Infrastructure Transformation Programme Expert Advisory Group (the Advisory Group):

- a) Since 14 September 2015, the Advisory Group has met two times.
- b) In the period 14 September 2015 to 29 February 2016, the total travel expenses incurred by the Advisory Group has been \$158.99 (includes GST).
- c) There has been 100 per cent attendance by all members at the two Advisory Group meetings.
- d) All members attended the two Advisory Group meetings.

- e) At engagement, members were asked to provide information regarding any potential conflicts of interest and the ongoing identification of conflicts of interest is managed at the Advisory Group meetings.
