Answer:

a) \$102,094.54 GST inclusive (1 October 2016 to 28 February 2017). One contract – Notice ID CN3402016.

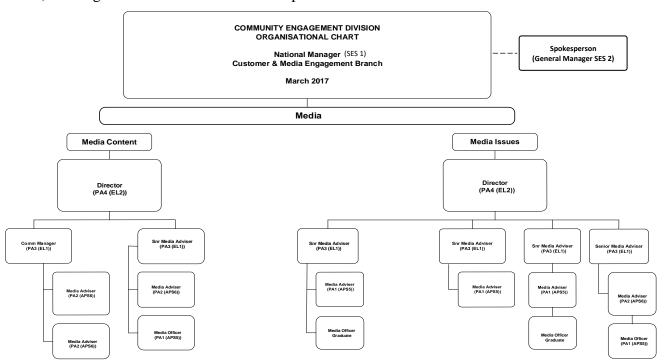
