Question:

- a) Can you provide a list of all 100 providers and peaks that attended Minister Wyatt's forum in Sydney on 22 February 2017 and any documentation pertaining to the forum? What was the purpose of the forum? What was discussed? What was the outcome of the forum?
- b) Why did the Government decide to exclude consumer advocates, employee representatives and other key aged care stakeholders from this forum?
- c) Mr Wyatt reportedly (by media release) told the forum that he supports the Aged Care Roadmap, however, "reform and the sequencing of reform were complex". Does this mean the Roadmap is Government policy or not? If yes, when will the Government deliver an implementation strategy for the Roadmap or at least formally respond to it? If no, what status does the Roadmap hold?
- d) Has Cabinet considered the Aged Care Roadmap and if not are there any plans for the Aged Care Roadmap to be considered by Cabinet?

Answer:

a) The Roadmap Roundtable, held in Sydney on 22 February 2017. A list of attendees from the sector is provided at Attachment A.

The purpose of the Roundtable was for the Minister to engage with the sector to understand its views on the Roadmap as a coherent framework presenting the short, medium and long-term goals for the sector.

- An agenda distributed to attendees at the event is provided at <u>Attachment B</u>. The outcomes of the forum will be taken into account when considering future reforms.
- b) The attendees for the Roundtable were selected by the Minister's office and included a mix of representatives to ensure the audience represented a broad cross section of the sector, including consumer organisations, with a strong focus on smaller, regional aged care providers.

- c) The Aged Care Roadmap, published in April 2016, was developed by the Aged Care Sector Committee and presents the sector's long-term reform vision. It is intended to guide the future direction of aged care policy and innovation.
- d) The Department of Health does not comment on Cabinet-related matters.
