Senator Siewert asked:

What date were the NDIA Operating Guidelines finished and published on the website?

Answer:

The Operational Guidelines critical to the commencement of the National Disability Insurance Scheme were first published prior to commencement of the trials on 1 July 2013.

Further sets of Operational Guidelines were published in December 2013 and January 2014 including a set which provide guidance on how the National Disability Insurance Agency makes decisions on what reasonable and necessary supports will be approved as part of a participant's plan.

The Operational Guidelines are reviewed and updated periodically based on scheme experience in the trial sites to ensure they are accurate, up-to-date and complete. For example, the Operational Guidelines dealing with the disability requirements and early intervention requirements were updated in January 2014 to include expanded lists of conditions that the Chief Executive Officer considers likely to meet elements of the disability requirements and early intervention requirements (refer to QON No. 506).

The Operational Guidelines are intended to be dynamic documents that will be updated regularly. It is expected that they will continue to be modified over time as they are informed by operational experience including feedback from participants and other stakeholders.
