b. Please provide the same breakdown of funding provided in 2012-13 and 2013-14 under the funding agreements which will now be offered under this sub-activity.

#### Answer:

In 2012-13 and 2013-14 Reconnect was part of the Housing Assistance and Homelessness Prevention Programme in Outcome 2: Housing. From 1 July 2014 Reconnect was moved to the Young People Sub Activity which is part of the Families and Children Activity in Outcome 2: Families and Communities. Reconnect is currently the only grant/component under the Young People Sub Activity. The current agreements cover the period from 1 July 2013 – 30 June 2016.
