### Question:

- a) Has there been a change to the department/agency's guidelines on study since the 2012-13 Budget Estimates (May 2012)? If yes, please provide details.
- b) For this financial year to date, detail all education expenses (i.e. in house courses and tertiary studies) for each portfolio department and agency. Include what type of course, the total cost, cost per participant, the employment classification of each participant, how many participants and the amount of study leave granted to each participant (provide a breakdown for each employment classification). Also include the reason for the study and how it is beneficial for the department/agency.

#### Answer:

a) There has been no change to the Department of Health and Ageing's guidelines on study since the 2012-13 Budget Estimates.

The National Health and Medical Research Council's (NHMRC) Study Assistance Scheme Policy and Procedures were reviewed in mid-2012 and the following changes were made:

- There is more emphasis on undergraduate rather than post-graduate qualifications.
- Financial support has been capped at 50 per cent of the upfront discounted course fee.
- In line with internal students, external/distance students will only be supported to attend compulsory course requirements (eg lectures, tutorials, residentials) that are scheduled during business hours. No additional study time will be approved for external students.
