**Question:**

I am interested in knowing how many clients or individuals have access to the six exceptional circumstances treatment sessions that are available, over the past five years. So, in total, the number of people who have accessed those—have used those last six sessions that were available, either in part or in full.

**Answer:**

Medicare Benefits Schedule (MBS) data on the number of persons who have accessed additional allied mental health services under 'exceptional circumstances' is presented in Question on Notice E12-282. See column A of Table 1 attached.
