**Answer:**

To date the National Disability Insurance Agency (NDIA) has conducted over 1,000 separate consultations with external stakeholders including service providers about the development of the National Disability Insurance Scheme.

Attachment A lists close to 300 service providers that have been engaged in at least one consultation with an NDIA representative in the past 12 months.

Many of the organisations listed have had more than one consultation with an NDIA representative.
