N.B: Whilst taxi costs are a component of domestic travel expenditure, they have been excluded from the above figures as they cannot be reported separately from total departmental taxi costs due to limitations in our financial reporting system. In addition, the above figures include travel expenses by external committee members as these expenses cannot be separately reported.

Staff are required to travel extensively domestically to administer, monitor and regulate the many health and sport programs provided to the Australian public.

Travel is also related to the Department of Health's obligations under Commonwealth legislation and international frameworks and treaties. This includes the Department's therapeutic goods regulatory role to ensure therapeutics manufactured overseas meet Australia standards. The Department also participates in international meetings, including those of the World Health Organisation, Organisation for Economic co-operation and Development and Asia-Pacific Cooperation, to protect and promote Australia's health interests and to improve regional and global health outcomes

Where required, the Ministers' offices were notified in accordance with the process outlined in our response to question 1.

4. Planned travel (as pre-loaded into the Department's approval workflow system) for the period 1 October to 31 December 2014 is \$767,165. This figure will change over this period as bookings may be amended or cancelled before the travel date and other travellers will make new bookings.

Travel for the remainder of 2014 will be undertaken as required to support the Department's obligations under commonwealth legislation, international frameworks and treaties, and to attend meetings to support the Government's health and sport agenda.
