 - 3) 3-6 months
 - 4) 6-9 months
 - 5) 12 months
 - 6) 24 months
 - 7) 2-5 years
 - 8) 6-10 years
 - 9) 10 20 years
 - 10) Over 20 years.
- b) For 2014-15:
 - 1) Provide a breakdown on the numbers of each payment types that were the subject of an IMP (including Special Benefit).
 - 2) How many IMP's were appealed at each stage of appeal, and what was the outcome of the appeal?
 - 3) How many Income Maintenance Periods (IMP) were imposed.
 - 4) Of the Income Maintenance Periods applied, detail the average IMP imposed.
 - 5) Provide data on the range of IMP's applied in the period.
- c) As of October 2015, how many IMP's are being served in total? Provide details of the range of IMP's currently being served.
