Senator Claire Moore asked:

1. Could you provide an outline of what improvements have been made to FOFMS from October 2013 until now?
2. Which departments and agencies currently use FOFMS?
3. What grant programmes are currently administered through FOFMS?
4. What additional functions will become available as a result of the March 2016 system release?
5. What other enhancements or changes be made as part of the March 2016 system release?
6. What departments and agencies are expected to start using FOFMS after the March 2016 system release?
7. What additional grant programmes will be administered through FOFMS after the March 2016 system release?
8. Can you provide details of what monies have been expended by the Department for the redevelopment of FOFMS since October 2013?
9. Can you provide a summary of the planned changes to be made to FOFMS in each systems release for the period to December 2017?
10. Do you expect that further funds for the redevelopment of FOFMS will be sort in the 2016 and 2017 budget rounds?
11. When do you expect the current redevelopment to be completed?

Answer:

1. Could you provide an outline of what improvements have been made to FOFMS from October 2013 until now?

From October 2013 – 30 June 2015, standard maintenance and the support of changes to existing business occurred. From 1 July 2015 – 30 October 2015, the following improvements have been made and will be available in March 2016:

- grants system core platform redevelopment to allow for increased availability and reliability
- an upgrade of the backend data quality module to increase capability
- improvements to the auditability
- improvements to the reconciliation of payments
- analysis of the standardisation of organisations and their addresses
- update of the data in FOFMS to allow for data segregation.

2. Which departments and agencies currently use FOFMS?

FOFMS is used by the:

- Department of Social Services (DSS)
- Department of the Prime Minister and Cabinet (PM&C)
- Department of Health (DoH)
- Department of Education and Training (DET) and
- National Disability Insurance Agency (NDIA).

3. What grant programmes are currently administered through FOFMS?

DSS administers grant programmes in the following areas:

- Families and Communities
- Housing and Homelessness
- Disability, Mental Health and Carers
- National Disability Insurance Scheme (NDIS).

Attachment A provides a list of the specific grants programmes administered in FOFMS.

4. What additional functions will become available as a result of the March 2016 system release?

The March 2016 major systems release is focused on a number of additional functions or enhancements that will be available to all system users including current and future agencies:

- integration of the Whole of Government 'SmartForms' solution administered by the Department of Industry, Innovation and Science
- integration of the Australian Business Number Lookup web service into vendor and applicant registration functions
- establishing system level automation of payment and transaction reconciliation between FOFMS and other payment systems
- streamlining processes to create records within FOFMS and payment systems to support faster implementation of granting programmes
- implementation of new enterprise data warehousing capabilities including cross-programme data analytics and reporting.

The March 2016 major systems release will also include non-functional changes which streamline existing business processes or improve the underlying platform. These changes are:

- increased automation of application processing speeding up the agreement drafting process
- increased visibility of variations to existing grant agreements within the system
- establishing system environments for FOFMS and its associated systems (e.g. Online Forms and Systems) to support high availability.

Additionally, tools to aid the calculation and payment of Social And Community Services (SACS) payments will be made available to DSS system users.

Not all of these functions are visible to users outside of agencies.

5. What other enhancements or changes be made as part of the March 2016 system release?

The answer to this question is incorporated in the response to question 4.

6. What departments and agencies are expected to start using FOFMS after the March 2016 system release?

Consuming Agencies have not been required to select a particular Hub at this stage. Decisions will be made by the ten consuming agencies in the next few months as part of the transition planning under the whole of government initiative.

7. What additional grant programmes will be administered through FOFMS after the March 2016 system release?

DSS will continue to administer all DSS grants programmes including any new programmes through FOFMS.

Information relating to the programmes other Departments are intending to administer through FOFMS will be determined by those Departments.

8. Can you provide details of what monies have been expended by the Department for the redevelopment of FOFMS since October 2013?

From October 2013 – 30 June 2015, standard maintenance and the support of changes to existing business occurred. From 1 July 2015 – 30 October 2015, \$2,069,512 has been expended in IT enhancements (outlined in question one), all of which has been funded through the 2015-16 budget allocation.

9. Can you provide a summary of the planned changes to be made to FOFMS in each systems release for the period to December 2017?

As part of the Streamlining Grants Administration Programme (SGA Programme), the Department is undertaking genuine co-design with government/key stakeholders including agencies currently using FOFMS and community sector organisations. This will ensure we develop business solutions which deliver value for government departments, reduce red tape for community service providers and individuals, and improve internal efficiency and effectiveness.

The scope of changes and functional enhancements to be included in each tranche of the SGA Programme will be informed by extensive engagement and co-design with government departments and community organisations.

This approach ensures strong understanding of all stakeholder needs and expectations are reflected in programme deliverables over the period to December 2017 and beyond.

10. Do you expect that further funds for the redevelopment of FOFMS will be sought in the 2016 and 2017 budget rounds?

The 2015-16 Budget identified future DSS funding of \$38,601,000 in 2016-17, \$13,841,000 in 2017-18 and \$1,789,000 in 2018-19. The Department is not expecting to seek further funds for this initiative.

11. When do you expect the current redevelopment to be completed?

The last IT release is currently scheduled for December 2017.
