THIS DEED OF VARIATION is made on 4 September 2014.

### **BETWEEN**

**COMMONWEALTH OF AUSTRALIA** (the Commonwealth) as represented by the Department of Social Services (the Department)

**AND** Nous Group (**the Supplier**) ABN 66086210344, an Australian company incorporated in accordance with the Corporations Act 2001 and having its registered office at Level 7, 54 Marcus Clarke Street, Canberra, ACT 2601

#### **PURPOSE**

- A. The Supplier and the Commonwealth, represented by the Department, entered into Official Order Number 90004717 dated 14 July 2014 (**the Contract**) for the provision of Project Management Services pursuant to and subject to the terms and conditions of Deed Number 60001485 between the Department and the Supplier.
- B. The parties have agreed to certain variations to the rights and obligations contained in the Contract.
- C. The parties wish to formally record those variations in the form of this Deed of Variation.

#### IT IS AGREED

1. The Contract is varied by the following amendments:

Due to increase of applications received, Phase 1 and 2 have required an increased amount of working hours than originally projected.

a) Item 12 - Fees, Charges and Expenses will be amended to:

Subject to acceptance of the Ordered Services by DSS payment for the Ordered Services will be made on receipt of a correctly rendered invoice, after the following milestones are completed.

24 December 2014 - Phase Three Final Deliverables \$167,695 (GST incl)
