**Senator McKenzie asked:** 

**Senator McKENZIE:** Okay. Excellent. I have asked this in the past, but I will ask again: with those properties that are leased, could you actually provide some detail around that? And I understand if you want that evidence to be in-confidence, but I would like to have that information.

Mr Pendleton: Yes.

Senator McKENZIE: You have listed in that answer three properties which are being leased in

Beijing. How much do those leases cost the ABC per annum?

**Mr Pendleton:** We will take that on notice for you, Senator. **Senator McKENZIE:** Mr Pendleton, I am pretty confident that you should have those figures at

hand.

Mr Pendleton: I actually don't...

Senator McKENZIE: ... About how much the leases were for, about who the leases were

actually with—that has been part of my questioning over the last two estimates.

Mr Pendleton: I can get it for you on notice. But I honestly don't have it with me.

Senator McKENZIE: You do not have it. Mr Scott, you do not have how much you pay in

leases?

**Mr Scott:** No, I do not have it, I am afraid, Senator. It is part of the diplomatic compound.

**Senator McKENZIE:** Yes, that is on the answer. So, of the staff that you have overseas, do the three that are located in Beijing have one of those residences each?

Mr Scott: I would have to check on that. I do not have that detail, I am afraid.

**Senator McKENZIE:** We have got three residences being leased in Beijing; we have got three staff members.

**Mr Scott:** Yes, I expect so. I will have to check that out. There have been and there are quite significant restrictions around our ability to operate in China, and I believe that this area that we are operating in is an area where many of the international reporting bases are, and it is like a converted apartment block. I will find out. I am not quite sure where they all live.

**Senator McKENZIE:** Yes, some more detail on that would be great.

**Mr Scott:** There would be more than half a dozen staff who operate in our Beijing bureau, some locally based and some from Australia—a cameraman, a reporter and the like. We can get detail on that for you.

**Senator McKENZIE:** I am referring to the staffing locations in answer No. 548 to a question from Senator Canavan, which lists our overseas staff. Could you also review that, if there are six working out of Beijing?

**Mr Scott:** I did not have the precise number.

**Senator McKENZIE:** They are journalists specifically?

**Mr Scott:** There are journalists, but there are others who work—there might be a translator, there might be a sound engineer. These are locally based staff.

# **Current guidelines for International assignments (effective from 2011):**

In the event that established accommodation is not available at an assignment location then an allowance will be provided to cover the cost of fully furnished rented accommodation. The allowance is calculated based on the host location and the family size using data provided by ECA International<sup>1</sup>.

As part of the staff employment contract, the ABC pays the agreed rent amount directly to the landlord.
