Australian Communications and Media Authority	4 vacant members - (The ACMA Act allows for the appointment of a Chair, Deputy Chair and up to seven other members, however it has been the policy of successive governments that the Authority is able to function effectively without all member positions being filled)
NBN Co Limited Board	2 Vacant Non-executive directors. Under the current Constitution, the Board may have a minimum of three and a maximum of nine directors. There are currently seven members appointed
Classification Board	1 vacant member since 2 September 2015. Covered by appointment of temporary Board members as required.
Classification Review Board	Convenor vacant since 6 February 2015 – Acting Deputy Convenor has acted as Convenor from 6 February 2015 to 6 June 2015 and 1 July 2015 to 30 June 2016. Deputy Convenor vacant since 7 December 2014 – Acting Deputy Convenor appointed from 7 December 2014 to 6 June 2015 and 1 July 2015 to 30 June 2016 (position has remained vacant when Acting Deputy Convenor has acted as Convenor whenever that office has been vacant) Member vacant since 17 June 2014 – acting Member appointed from 7 December 2014 to 6 June 2015 and 1 July 2015 to 30 June 2016 Member vacant since 7 December 2014 – acting Member appointed from 7 December 2014 to 6 June 2015 and 1 July 2015 to 30 June 2016. Member vacant since 7 December 2014 – acting Member appointed from 1 July 2015 to 30 June 2016.
