Since the change of Prime Minister on 14 September, 2015:

- 4. List each member's attendance at meetings;
- 5. how does the board deal with conflict of interest;
- 6. what conflicts of interest have been registered;
- 7. what remuneration has been provided to board members;
- 8. how does the board dismiss board members who do not meet attendance standards?
- 9. Have any requests been made to ministers to dismiss board members?
- 10. Please list board members who have attended less than 51% of meetings
- 11. what have been the catering costs for the board meetings held during this period? Please break down the cost list

Answer:

- 1. The nbn Board has met five times since 14 September 2015.
- 2. Directors are paid a travel allowance as prescribed by the Remuneration Tribunal Determination: Official Travel by Office Holders. The amount of this allowance varies depending upon the city in which the Director is attending a Board meeting. The travel allowance is adjusted in accordance with Section 3.4 of the Determination where necessary. In addition, air travel is either booked through nbn's travel service provider or reimbursed to a Director who may book his/her own air travel. The level of air travel either booked or reimbursed by nbn is in accordance with Table 2A Tier 1 of the Remuneration Tribunal Determination: Official Travel by Office Holders and the Determination: Remuneration and Allowances for Holders of Part-Time Public Office.
- 3. Average attendance over the five meetings of the nbn Board is 6.4.
