In each case please identify the subject matter, duration, cost and method of procurement as above, and the name of the consultant if known.
- 3. Have any consultancies not gone out for tender?
  - (a) List each, including name, cost and purpose
  - (b) If so, why?

#### Answer:

- 1. The ACMA undertook nine consultancies from 14 September 2015 to 29 January 2016 with a total value of \$480,065 (GST inclusive). The details for each consultancy are provided in Table 1 of Attachment A.
