The **Director of National Parks** spent \$174.59 (GST inclusive) on hospitality.

The **Bureau of Meteorology** spent \$8,558.87 (GST inclusive) on hospitality.

The **Sydney Harbour Federation Trust (the Trust)** spent \$12,114.60 (GST inclusive) on hospitality.

The remaining portfolio agencies have no hospitality events, that have occurred within the specified period.
